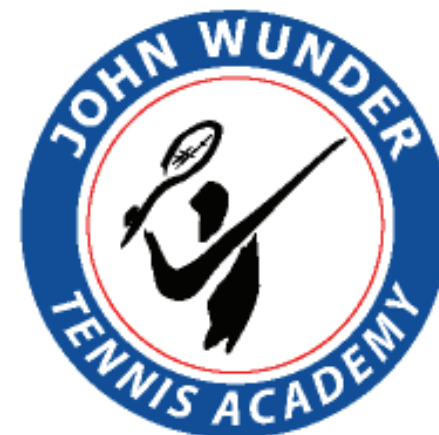

GROUP LESSONS:

- ****To validate class registration all forms must be signed by the adult participant or parent /guardian for junior participant. (See release statement on back panel)**
- **Payments:** Final payment is due on or before the first day of class. A \$10 surcharge will be assessed on late payments.
- **Refunds:** No refunds for any of the following: late arrival, early departure, absence from class, or withdrawal from class. We reserve the right to dismiss any student whose behavior is detrimental to the class.
- **Pro Rate:** If joining a class in mid-session, you will not be charged for previous dates missed.
- **Make-ups:** Make-ups are not permitted.
